Board Meeting Structure/ Responsibilities

- Regular monthly meetings will be held at a time and location selected by board. Special meetings may be called by the Coordinator or at the request of two members
- A majority of the voting members of the board shall constitute a quorum for the transaction of business at any meeting of the CVB.
- CVB shall distribute an annual report during the first quarter of each year. The coordinator is responsible for delivering the report to include progress, activities of the CVB and provide budgets for the upcoming year.
- The CVB shall effectively administer the City of Crookston lodging tax for the purpose of promoting tourism, conventions, seminars, trade shows, sporting events and other activities that will bring overnight stays
- The CVB board shall determine all committees and subcommittees. Committee membership is not limited to the CVB board.
- The CVB board will form self-governing guidelines to include; by laws, code of conduct for board and committee members as well as a defined policy and procedure guideline.
- Terms of office will be determined by board and finalized by voting members
