

PROPOSED MINUTES OF THE CROOKSTON CITY COUNCIL, POLK COUNTY, MINNESOTA. THE FIRST REGULAR COUNCIL MEETING OF JUNE 28, 2021 CROOKSTON HIGH SCHOOL.

Mayor Stainbrook called the meeting to order at 7:00 p.m. and requested all present to stand to recite the Pledge of Allegiance.

ROLL CALL

Council Members present in answer to roll call were: Joe Kresl, Dylane Klatt, Tom Vedbraaten, Wayne Melbye, Kristie Jerde, Steve Erickson, Clayton Briggs and Donald Cavalier.

Staff present: Amy Finch, Brandon Carlson, Scott Butt, Greg Hefta, Paul Biermaier, Chad Palm, Ryan Lindtwed, Darin Selzler and Ashley Rystad.

CROOKSTON FORUM

PRESENTATION AND PUBLIC INFORMATION ANNOUNCEMENT

4.01 Stefanie Okroi gave detail to the Council about the options of renting two classrooms at Washington School for a daycare program. The initial plan is to be open by September 1, 2021, but with the licensure coming from Minneapolis and with the State of Minnesota being backed up, the processing time could get delayed. Stefanie is hoping with the location already being in a school that has regular inspections this could help move the process along faster. Amy Finch, City Administrator, added further detail saying the focus of the daycare will be on infants and toddlers. At some point we may bring forward to the City Council a proposal to help extend a sidewalk on the property.

- 8.01 Ashley Rystad, Deputy City Clerk, addressed the Council with a revised updated resolution omitting Noelle Nelson's Payment, instead the timeline was elapsed. Motion was made by Council Member Klatt, Seconded by Council Member Briggs. It was duly carried to approve the revised Rental Rehabilitation Loan Program, Deferred Loan Repayment Agreement and Mortgage for Noelle Nelson.(Res No 27267)
- 8.02 Motion was made by Council Member Kresl, Seconded by Council Member Cavalier and duly carried to approve the Resolution for Commercial Rehabilitation Loan Program Deferred Loan Repayment Agreement and Mortgage for Noelle Nelson. (Res No 27268)

- 8.03 Motion was made by Council Member Briggs, Seconded by Council Member Jerde and duly carried to approve the Resolution to approve an Intermediary Relending Program (IRP) Loan Repayment Agreement and Mortgage with TJC, INC (Res No 27269)
- 8.04 Motion was made by Council Member Kresl, Seconded by Council Member Erickson and duly carried to approve the Resolution to approve the School Resource Officer Service Agreement between Independent School District #593 and the City of Crookston. (Res No 27270)
- 8.05 Motion was made by Council Member Cavalier, Seconded by Council Member Briggs and duly carried to approve the Resolution authorizing and/or ratifying the sale or disposal of Real Property Lot 6, Block 4 of Evergreen Estates Subdivision. Amy Finch, City Administrator, made a brief statement that this was property sold in 1998 and the City realized and discovered that some items were not recorded with County, so this process today is just to ratify that sale and allow us to property record the proper documents. (Res No 27271)
- 8.06 Motion was made by Council Member Erickson, Seconded by Council Member Klatt. Amy Finch, City Administrator, addressed the Council and stated that the City has had a recent public hearing on the Wellhead Protection Plan and the City did receive some additional comments from the DNR after the date that the City would like to address. After the discussion it was duly carried to approve the Resolution calling a Public Hearing for the Wellhead Protection Plan (Res No 27272)
- 8.07 Mayor Stainbrook asked if any Crookston Housing Economic Development Authority (CHEDA) Board members would like to come to the lectern and address the City Council. Kurt Heldstab, President of CHEDA Board addressed the Council stating "CHEDA has heard clearly the complaints of the Council and citizens and take them seriously. Since last Tuesday I've been unable to set a date for a CHEDA meeting so we can do our due diligence on formulating options with CHEDA board approval. At this time I would request additional time to set such a meeting. I see no reason to rush this process."
- 8.08 Motion was made by Council Member Klatt, Seconded by Council Member Cavalier. Council Member Vedbraaten asked if the City has all the items in order. At the Public Hearing, many times people said to slow down and do this right. Amy Finch, City Administrator, discussed with the Council about the Public Hearing timelines and after discussion was made between Council Members and Kurt Heldstab President of CHEDA. Deputy City Clerk, Ashley Rystad, stated there was already a first and second motion on the table and Mayor asked if there was any further discussion. City Administrator, Amy Finch, stated this vote tonight was to approve to hold a public hearing on July 12, 2021 and at that Council meeting the Council Will have the opportunity to vote the resolution up or down. Voting in the affirmative: Council Members Kresl, Klatt, Melbye, Jerde, Briggs and Cavalier. Voting in the negative: Council Members Erickson and Vedbraaten with a majority vote it passed to approve the Resolution calling a Public Hearing on the Question of Modifying the enabling Resolutions Concerning the Crookston Housing and Economic Development Authority.(Res No 27273)
- 8.09 Motion was made by Council Member Briggs, Seconded by Council Member Jerde. Mayor Stainbrook asked for discussion. Council Member Vedbraaten asked about a meeting that we could take the blocks off the sidewalks and cement the centers and call it maintenance and I haven't really ever heard anybody to say that they want two lanes a bike path but we couldn't do anything with the sidewalks but it would not be ADA accessible. Amy Finch, City Administrator, addressed the Council and said this study would develop the alternatives for the City Council to have final approval on. The study is just to determine and work through what those recommendations and alternatives will be. The City Council has already agreed to enter into a joint powers agreement with MnDOT and what we are discussing tonight is the consultant selection and what the City share would be. After further discussion it was duly carried to approve the Minnesota Department of Transportation (Mn Dot) Corridor Study Consultant selection to SRF Consulting Group. (Res No 27274)

MODIFYING RESTATED CROOKSTON HOUSING AND ECONOMIC DEVELOPMENT AUTHORITY ENABLING RESOLUTION

WHEREAS, Minnesota Statutes Section 469.090 to 469.108 authorizes the creation by city resolution of an Economic Development Authority with the powers set forth in said sections.

WHEREAS, by Resolution No. 18599 titled: Crookston EDA Enabling Resolution, adopted August 25, 1987, the city of Crookston established an Economic Development Authority known as Crookston Development Authority.

WHEREAS, Resolution No. 18599 was amended in certain respects by Resolution No. 24316 titled: amend Crookston Development Authority Enabling Resolution adopted March 14, 2006, made changes primarily in the composition of the Board of Commissioners.

WHEREAS, Resolution No. 24768 titled: Restated Crookston EDA Enabling Resolution adopted December 18, 2007, restated the Crookston Economic Development Authority Enabling Resolution and amended Resolution No. 18599 and Resolution No. 24316.

WHEREAS, Resolution No. 24768 established an Economic Development Authority pursuant to Minnesota Statute Section 469.091.

WHEREAS, Resolution No. 24768 named the Economic Development Authority as the Crookston Housing and Economic Development Authority.

WHEREAS, the Crookston Housing and Economic Development Authority has the powers of an Economic Development Authority in Minnesota Statutes 469.090 to 469.108 and the powers of a Housing and Redevelopment Authority under Minnesota Statutes Section 469.001 to 469.047 or other law and of a city under Minnesota Statutes Section 469.124 to 469.134 or other law.

WHEREAS, the City Council of the City of Crookston finds that economic development and housing redevelopment within the city can be best promoted and accomplished by having seven (7) members of the City Council serve as the Commissioners of the Crookston Housing and Economic Development Authority.

WHEREAS, the City Council of the City of Crookston finds that the purpose of the Crookston Housing and Economic Development Authority may best be served by imposing limits upon the actions of and exercise of any powers by the Crookston Housing and Economic Development Authority.

WHEREAS, Minnesota Statutes Sections 469.092 and 469.093 authorize the modification of an Economic Development Authority Enabling Resolution.

WHEREAS, the City Council of the City of Crookston did and has in accordance with Minnesota Statute Section 469.093 provided public notice and conducted a public hearing on July 12, 2021, concerning the modification of the Enabling Resolution with respect to the Crookston Housing and Economic Development Authority at which hearing all persons wishing to express his, her, or their views were given an opportunity to be heard on the proposal to modify the Enabling Resolution with respect to the Crookston Housing and Economic Development of seven (7) City Council members as the Commissioner of the Authority and limiting the actions and exercise of any powers without the prior approval of the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City of Crookston:

1. <u>Creation of Authority.</u> An Economic Development Authority is established pursuant to Minnesota Statute Section 469.091.

- 2. <u>Name.</u> The name of the Economic Development Authority herein established is the Crookston Housing and Economic Development Authority (CHEDA), herein after referred to in this Resolution as "Authority".
- 3. <u>Membership.</u> The Authority shall consist of seven (7) Commissioners who shall be appointed by the City Mayor with approval of the City Council and who shall be members of the City Council. The City Council may set the term of the Commissioners who are members of the City Council to coincide with their term of office as members of the City Council.
- 4. **Duties.** The Authority has the duties set forth in and shall operate in accordance with Minnesota Statutes Sections 469.090 to 469.108 and this Resolution.
- 5. **Powers.** Subject to the limitations set forth in paragraph 6 below, the Authority has the powers of an Economic Development Authority in Minnesota Statutes Sections 469.090 to 469.108, the powers of Housing and Redevelopment Authority under Minnesota Statutes Sections 469.001 to 469.047 or other law, and of City under Minnesota Statutes Sections 469.124 to 469.134, or other law.
- 6. Limitations. The Authority's actions are limited as follows:
 - a. The Authority must not exercise any powers without the prior approval of the City Council;
 - b. Except when previously pledged by the Authority, the City Council may by Resolution require the Authority to transfer any portion of the reserves generated by activities of the Authority that the City Council determines is not necessary for the successful operation of the Authority to the debt service fund of the City to be used solely to reduce levies for bonded indebtedness of the City;
 - c. The sale of all bonds or obligations issued by the Authority, be approved by the City Council before issuance;
 - d. The Authority follow the budget process for City Departments as provided by the City and as implemented by the City Council and Mayor;
 - e. All official actions of the Authority must be consistent with the adopted Comprehensive Plan of the City and any official controls implementing the Comprehensive Plan;
 - f. The Authority submit all planned activities for influencing the action of any other Governmental agency, subdivision, or body to the City Council for approval; and
 - g. The Authority submit its administrative structure in management practices to the City Council for approval.

AN ORDINANCE OF THE CITY OF CROOKSTON, MINNESOTA AUTHORIZING AND CREATING A COMMUNITY DEVELOPMENT DEPARTMENT.

THE CITY OF CROOKSTON ORDAINS, as follows

The following describes the intent and purpose of this Ordinance:

Pursuant to City of Crookston, Minnesota Charter Section 5.03, the City Council may establish by Ordinance a City Department and describe its functions;

It is desirable that the City of Crookston have a department with a director to build relationships with individuals and organizations to obtain, retain, and secure business entities within the City of Crookston;

The City of Crookston Municipal Code shall be amended as follows and the City of Crookston ordains:

- 32.162 Establishment.
- 32.162.A The Community Development Department is hereby established. The head of the Department shall be the Community Development Director.
- 32.162.B The head of the Community Development Department shall be responsible to the City Administrator and shall make and file reports as may be requested by the City Administrator.
- 32.162.C The Director of Community Development shall make recommendations to the City ٠ Administrator in conjunction with the programs and policies of the City of Crookston related to businesses, development, and planning. The Director coordinates and implements goals and programs of economic development that promote the growth and retention of a vital economy within the City. The Director develops, maintains, and updates the Community Development Department's long and short ranged developmental goals. The Director creates and maintain an inventory of vacancies of commercial and industrial properties in the City and develops strategies to decrease vacancies within the City. The director develops and coordinates economic development, marketing strategies, and growth management process. The director works with private businesses and public agencies to enhance the economic vitality and viability within the City. In coordination with the City Administrator and other City directors, the Community Development Director evaluates large developmental projects within the City. The Community Development Director oversees and builds relationships with individuals and organizations and is to be a creative force in obtaining, retaining, and securing business entities and manufacturers within the City.






2 MAIN LEVEL FLOOR PLAN - MEN'S 101

Polk County Fire Departments and the City of Crookston, Minnesota Fire and Rescue Services Mutual Aid Agreement

Purpose

This Agreement is made pursuant to Minnesota Statutes, Section 471.59 which authorizes the joint and cooperative exercise of powers common to contracting parties. The intent of this Agreement is to make equipment, personnel and other resources available to governmental units from other governmental units.

Definitions

1. "Party" means a governmental unit as defined by Minnesota Statues,

Section 471.59, subd. 1 (b). "Parties" shall collectively mean more than one Party.

2. "Requesting Official" means the person designated by a Party who is responsible for requesting Assistance from other Parties.

3. "Requesting Party" means a Party that requests Assistance from other Parties.

4. "Responding Official" means the person designated by a Party who is responsible to determine whether and to what extent that Party should provide Assistance to a Requesting Party.

5. "Responding Party" means a Party that provides Assistance to a Requesting Party.

6. "Assistance" means:

Fire and/or emergency medical services personnel and equipment:

Procedures

1. **Request for Assistance**. Whenever, in the opinion of a Requesting Official, there is a need for Assistance from other Parties, the Requesting Official may call upon the Responding Official of any other Party to furnish Assistance.

2. **Response to Request**. Upon the request for Assistance from a Requesting Party, the Responding Official may authorize and direct that Party's personnel to provide Assistance to the Requesting Party. This decision will be made after considering the needs of the Responding Party and the availability of resources.

3. **Recall of Assistance**. The Responding Official may at any time recall such Assistance when in his or her best judgment or by an order from the governing body of the Responding Party, it is considered to be in the best interests of the Responding Party to do so.

4. **Command of Scene.** The Requesting Party shall be in command of the mutual aid scene. The personnel and equipment of the Responding Party shall be under the direction and control of the Requesting Party until the Responding Official withdraws Assistance.

Workers' Compensation

Each Party shall be responsible for injuries or death of its own personnel. Each Party will maintain workers' compensation insurance or self-insurance coverage, covering its own personnel while they are providing Assistance pursuant to this Agreement. Each Party waives the

right to sue any other Party for any workers' compensation benefits paid to its own employees or volunteer or their dependents, even if the injuries were caused wholly or partially by the negligence of any other Party or its officers, employees, or volunteers.

Damage to Equipment

Each Party shall be responsible for damages to or loss of its own equipment. Each Party waives the right to sue any other Party for any damages to or loss of its equipment, even if the damages or losses were caused wholly or partially by the negligence of any other Party or its officers, employees, or volunteers.

Liability

1. For the purposes of the Minnesota Municipal Tort Liability Act (Minn. Stat. Ch. 466), the employees and officers of the Responding Party are deemed to be employees (as defined in Minn. Stat. § 466.01, subd. 6) of the Requesting Party.

2. The Requesting Party agrees to defend and indemnify the Responding Party against any claims brought or actions filed against the Responding Party or any officer, employee, or volunteer of the Responding Party for injury to, death of, or damage to the property of any third person or persons, arising from the performance and provision of Assistance in responding to a request for Assistance by the Requesting Party pursuant to this Agreement.

For purposes of determining total liability for damages pursuant to Minn. Stat. § 471.59, subd. 1a(b), the Parties are considered a single governmental unit and the total liability of the Parties shall not exceed the limits on governmental liability for a single governmental unit as specified in Minn. Stat. § 466.04, subd. 1.

The intent of this subdivision is to impose on each Requesting Party a duty to defend and indemnify a Responding Party for claims arising within the Requesting Party's jurisdiction subject to the limits of liability under Minnesota Statutes, Chapter 466. The purpose of creating this duty to defend and indemnify is to simplify the defense of claims by eliminating conflicts among defendants, and to permit liability claims against multiple defendants from a single occurrence to be defended by a single attorney.

3. No party to this Agreement nor any officer of any Party shall be liable to any other Party or to any other person for failure of any Party to furnish Assistance to any other Party, or for recalling Assistance, both as described in this Agreement.

Charges to the Requesting Party

1. No charges will be levied by a Responding Party to this Agreement for Assistance rendered to a Requesting Party under the terms of this Agreement unless that Assistance continues for a period of more than 8 hours. If Assistance provided under this Agreement continues for more than 8 hours, the Responding Party will submit to the Requesting Party an itemized bill for the actual cost of any Assistance provided after the initial 8-hour period, including salaries, overtime, materials and supplies and other necessary expenses. The Requesting Party will reimburse the Party providing the Assistance for that amount.

2. Such charges are not contingent upon the availability of federal or state government funds.

Duration

This Agreement will be in force for a period of 10 years from the date of execution. Any Party may withdraw from this Agreement upon thirty (30) days written notice to the other Party or Parties to the Agreement.

Execution

Each party hereto has read, agreed to and executed this Mutual Aid Agreement on the date indicated.
